GDPR POLICY

As from May 2018 it is a requirement for Guildford Rowing Club (the "Club") to notify you as a member (or in the case of a junior member under the age of 18, the parent or guardian of the junior member) or prospective member (in the case of a membership inquiry), of how we may store personally identifiable data. For all new, existing and prospective members (or their parents or guardians for junior members) we maintain contact details such as address, contact telephone numbers and emails, Date of Birth and age, details of gender, membership category and rowing details. We maintain this data on a secure database which can only be accessed by authorised Club officials (or in the case of juniors, authorised junior coaches), or on paper with limited access allowed to Club officials or coaches. We use this data to enable club officials to contact you in relation to club matters. We may also send you details of matters that are connected with rowing (such as rowing courses, or rowing clothing and equipment) but we will not share your information with any third party without your express prior consent, save in the case of a medical emergency or as required by the Police or other competent authority. Anyone can request details of the information we hold at any time by contacting a Club officer. Full details are available on the website. You have a right to review copies of personal information by contacting the Secretary of the Club, full details contained in the Guildford Rowing Club Data Protection and Privacy Policy a copy of can be found on the Club website.

In addition, we know that Club members may use email lists, WhatsApp groups and other forms of communication such as Twitter etc. in relation to communicating with each other in connection with rowing related matters. These are neither maintained nor controlled by the Club and are private matters between Club members.
